Introduction

This resource guide was created to highlight the agencies, programs, employers, and organizations that may be useful to current and prospective residents as they determine the building blocks of independence, and design a supported and successful life at Gracious Grounds. Gracious Grounds staff regularly receive inquiries regarding what resources and programs are available in Ottawa County. This guide was developed in response to those questions, and serves to share the many resources available. The navigation tips and helpful hints give insight into how to move with a little more ease through what can be a complex system.

QR Codes

Throughout this guide there are QR Codes next to each website link so you can connect to the website quickly with your mobile device.

What is a QR Code?

A QR Code allows you to access a website by scanning it with your smartphone or tablet.

How to Use One:

- Open your photo app as though you are going to take a picture.
- 2 Hold your device over the QR Code so that it's clearly visible within your smartphone's screen.
- **3** The phone will scan the code. Note: On some devices, you may have to press a button to snap a picture in order for the device to read the QR code.
- 4 A small link will pop up. Click the link and your device will navigate to the intended destination.

Michigan Department of Health and Human Services (MDHHS): MI Bridges

Description

The Michigan Department of Health and Human Services (MDHHS) provides a variety of services to the residents of Michigan. MDHHS offices are located in every county; however, it is highly recommended that people work with MDHHS benefits online. MI Bridges is the online site that connects Michigan residents to MDHHS. You are able to apply for benefits, upload verification documents, manage your case, and explore resources from this site. You can use your computer, tablet or mobile phone to access this site at any time and apply for healthcare coverage, food assistance benefits, cash assistance, and utilities assistance through State Emergency Relief (SER) funds.

Eligibility

Eligibility for MI Bridges is based on a number of factors including: monthly income, countable cash assets, and number of individuals in your household.

Helpful Hints

- Applying online is the best method to apply because you can quickly communicate with a MDHHS worker. Without an online account, you would have to wait for these messages to come by mail. If you experience any problems with the MI Bridges online assistance application, call the MI Bridges Help Desk at 844-799-9876. If you need help with using MI Bridges online, MI Bridges Navigators are available for one-on-one assistance. Go to "Help" on the website and search for partners.
- If you prefer to apply in person you will be required to complete an application form. It is recommended that you complete the application before you come to the office. Make sure you take any and all required documents, such as your birth certificate or driver's license, with you to your appointment.

- After you complete an application your case is assigned to an MDHHS specialist who will conduct a phone interview to clarify any information and assess your eligibility for the programs you requested. At this time the specialist may let you know about any other documents you will need to submit. You will be asked to show proof of much of the information you provided on your application. Most proof, or verification, must be "current" and dated within the last 30 days. They may need to contact a third party, such as your landlord or employer, in order to verify your situation. Your signature on your application for assistance gives the specialist permission to do so. You will have 10 days to return this required documentation. If you need an extension or are having trouble getting these required documents, contact the specialist to get an extension or explore other options for verification. Otherwise, you risk your application being denied.
- If applying for Cash, Food, Medical & Emergency Assistance, have the following documents and information on hand:
 - Social Security numbers for everyone in the household who is applying
 - Income (current or date it stopped)
 - Application or receipt of unemployment compensation benefits
 - Assets (bank account statements, 401(k) and other investment account balances, investment accounts, trust funds, etc.)
 - Shelter expenses (rent receipt, mortgage payment, property tax bill, homeowner insurance, heat, electric, phone, water, etc.)
 - Medical or health insurance card
 - Unpaid Medical bills
 - Shutoff notices for shelter, heat or utilities
 - Immigration status
 - Marriage certificate
 - Divorce decree
 - Paternity acknowledgment
 - Pregnancy, expected date of delivery, and number of children expected

MDHHS has to respond with a determination on whether or not you will receive benefits within the following timeline:

Reporting Responsibilities

It is your responsibility to report changes that might affect your eligibility or benefit amount within 10 days of the change. This includes changes to your income, job status, assets, and family and living arrangements. Your specialist will tell you if different reporting rules apply to you.

Redetermination of Eligibility

After your case is opened, your eligibility will be re-determined from time to time. You will have your redetermination paperwork mailed to your home or sent to your MI Bridges account 30 days prior to the due date. You will fill out a redetermination form, provide new verification of information, and be interviewed, if necessary. Some programs do not require an interview. Each program has its own requirements.

Repayment of Benefits

If you or anyone in your household receives benefits they are not eligible for, all adults in the household are responsible for paying back the extra benefits, even if they no longer live in the home. The benefits must be paid back even if MDHHS makes the error. MDHHS may keep part or all of your benefits to repay the benefits you received in error.

What steps do I take if I disagree with an action taken on my case?

First, discuss it with your caseworker. If this does not resolve your issue, you may contact your caseworker's supervisor. In some instances, you may also have the right to ask for an administrative hearing. Your caseworker or supervisor can tell you if an administrative hearing is an option. Is it possible to request a different caseworker? Yes, but only after you have already worked with both your caseworker and your caseworker's supervisor to resolve the problems you are having. If you have done that, and you still want a different caseworker, you may submit a written request to the county director or district office manager for his or her consideration. In your request, include the reason for the request and the steps you have already taken to resolve the problem. A list of county directors and district office managers can be found at:

My case is closed but I need additional information, who should I contact?

Contact the local office that most recently handled your case.

If I am not a member of a case how can I get information about a case?

Confidentiality laws do not allow MDHHS to release case information to anyone who is not a member of that case. Sometimes, a member of the case can authorize another person to receive case information. The case member (who must be 18 or older) should contact his or her caseworker to find out if this is possible, and if so, how to arrange it. However, you may report information about any case at any time

Michigan Department of Health and Human Services (MDHHS): Home Help

Description

The Home Help program provides funding for qualified individuals to hire someone to assist them with their activities of daily living. It is designed to support individuals who wish to live independently, rather than live in an adult foster care home, home for the aged, or nursing facility. The Home Help program will pay for a direct care worker, friend or family member to provide the following activities of daily living:

- Eating or Feeding
- Bathing
- Dressing
- Grooming
- Moving throughout the home
- Transferring from one position to another
- Using the toilet
- Administering or setting up medicine
- Laundry

- Light housework
- Meal preparation/clean up
- Shopping for essential items
- Travel for shopping/laundry
- Complex Care (including catheters, leg bags, colostomy care, bowel program, suctioning, specialized skin care, range of motion exercises, peritoneal dialysis, wound care, respiratory treatment, ventilators, or injections).

Eligibility

Assistance is available if you are eligible for Medicaid and require physical assistance with at least one activity of daily living. An adult services worker will complete an assessment in your home to determine whether you qualify for assistance through the Home Help program.

Community Mental Health (CMH)

Description

Community Mental Health (CMH) is a public provider of services for people with intellectual/developmental disabilities, serious mental illness, and/or substance use disorders.

Eligibility

CMH services are available to residents of Ottawa County who have Medicaid or are uninsured, and who are eligible for services as defined by the Michigan Mental Health Code.

Services Available

Community Living Services (CLS)

Community Living Supports are supports used to increase or maintain personal self-sufficiency, facilitating an individual's achievement of his goals of community inclusion and participation, independence or productivity. The supports may be provided in the participant's residence or in community settings (including, but not limited to, libraries, city pools, camps, etc.)."

Eligibility Determination for CLS

CLS services are assessed by using the tools provided by CMH. The tools include the CLS assessment, the psychosocial, the Intervention and Template/Guide, the Net Analysis Tool for Support Time, the Weekly Schedule, the Level of Care Grid, and the UM Guide Sheet. These tools were developed to be used as a guide for service requests, and are to be utilized by case holders to obtain a full picture of a consumer's CLS needs. The goal of these tools is to provide a comprehensive and complete review of the medical necessity of CLS in each of the areas assessed (Behavioral Supports, Community Integration, etc.). These tools will also assist case holders in developing a CLS plan which will be incorporated into a consumer's individualized plan of service. Once the services are determined to meet medical necessity criteria and the authorizations are approved, the plan will be able to be signed off on and will become effective at that time.

Helpful Hints For CLS

- When going through the evaluation process:
 - Indicate any areas of complete independence. This includes tasks that are successfully completed with zero prompts or assistance.
 - Be very clear in identifying any portion of a task that involves the aid of prompts or support to be successfully completed. (e.g. Grocery shopping independently -Consider each step: Deciding meals to make, creating a grocery list, getting to/ from store, transporting groceries through the store and into the residence, price comparison shopping, staying within purchasing budget, locating items in the store, paying for items, stamina for the duration of the task, and the frequency of trips needed to effectively meet any limitations, etc.)
- Anyone who is denied for services has the right to appeal the decision and ask for a second evaluation.
- An individual or family may request to work with an independent agency, in place of CMH, for case management.
- When transferring to Ottawa County, having an existing case manager assist with verifying the need for services that are currently provided may be helpful in the evaluation process.

Mental Health Supports

Health and Wellness

Ottawa Health Link is a CMH program focused on providing health and wellness opportunities for people living with Intellectual and Developmental Disabilities (IDD) in Ottawa County. The program is working to address barriers to wellness faced by people living with IDD. Members gain access to appropriate fitness facilities, low impact exercise opportunities, diet and nutritional education, outdoor activities and social engagement.

Eligibility

IDD individuals who are over 18 years old, and receiving services with CMH. Gracious Grounds residents have previously used HealthLink to receive free memberships to Planet Fitness and Spring Lake Fitness and Aquatic Center.

Healthcare

Pathways to Better Health

Ottawa Pathways to Better Health is a program designed to help people access community services to improve their health and decrease unnecessary hospitalizations and emergency department visits. Each Pathways participant is paired with a Community Health Worker (CHW) who will help identify individual needs and goals and serve as a link to health and social services. There is no fee for qualifying individuals.

Eligibility

- 18 years old (or older) or pregnant
- Lives in Ottawa County (including 49417 zip code)
- Has Medicare and/or Medicaid (enrolled or eligible)
- And has two or more self identified chronic health conditions (such as diabetes, depression, anxiety, heart disease, arthritis, asthma, hypertension, or long-term pain)

What is a Community Health Worker (CHW)?

A Community Health Worker (CHW) is a trusted member of your community who understands your needs and will link you to health and social services. CHWs walk alongside clients to set goals and assist in achieving them. A CHW will:

- Meet with you at your convenience
- Help you set goals
- Guide you through the healthcare system
- Connect you to medical care for your specific needs (primary care doctor, dental, mental health, specialty, substance abuse treatment)
- Help you manage your health conditions and prescriptions
- Help you reduce hospital and emergency room visits

- Connect you to community services and resources (food, clothing, housing, financial and utility assistance, transportation, education, employment)
- And much more

Medicaid/Medicare

Medicaid provides health coverage to eligible low-income adults, children, pregnant women, elderly adults, and people with disabilities. Medicaid is carried out by states according to federal requirements. Medicaid plans cover medically necessary services such as an ambulance, chiropractic, doctor visits, emergency care, family planning, health checkups, hearing and speech, home health care, hospice care, hospital care, shots, lab and x-ray tests, medical supplies, medicines, mental health services, physical and occupational therapy, podiatry, prenatal care and delivery, surgery, and vision.

Medicare is the federal health insurance program for people who are 65 and older, certain younger people with disabilities, and people with End-Stage Renal Disease. There are three parts of Medicare that cover specific services. Medicare Part A covers inpatient hospital stays, care in a skilled nursing facility, hospice care, and some home health care. Medicare Part B covers certain doctor's services, outpatient care, medical supplies, and preventative services. Also helps cover the cost of prescription drugs, including shots or vaccines. Medicare Part D helps cover the cost of prescription drugs, including shots or vaccines.

Eligibility

Medicaid - All of the health care programs in Michigan have an income test, except Children's Special Health Care Services, and some of the programs also have an asset test. These income and asset tests may vary with each program. For some of the programs, the applicant may have income that is over the income limit and still be able to obtain health care benefits when their medical expenses equal or exceed their deductible (formerly known as spend-down) amount.

Medicare - Generally, Medicare is for people 65 or older. You may be able to get Medicare earlier if you have a disability, End-Stage Renal Disease (permanent kidney failure requiring dialysis or a transplant), or ALS (also called Lou Gehrig's disease).

Helpful Hints:

- Medicare-Medicaid Assistance Programs (MMAP): There are special programs that can help you understand and select Medicare and Medicaid plans, and provide free health insurance counseling for people with Medicare. MMAP counselors can help explore Medicare options and help individuals sign up for new Medicare plans. Love in Action: Health and Dental Clinic

The Love in Action Health Clinic provides access to quality care and referrals to area adults who are uninsured or unable to afford it (underinsured) regardless of geographical location

The Love in Action Dental Clinic provides basic dental services and referrals for adults 18 years or older who are either uninsured or under-insured and meet financial eligibility on intake. Licensed dentists, hygienists, and compassionate dental staff volunteer their time to provide basic care.

Priority Health Medicare: Papa Pals

Papa services include visits from Papa Pals, friendly helpers who can provide companionship and support both in-person and virtually. Papa Pals are supported by social care specialists who provide an extra layer of help with things like navigating your benefits, the health care system, your community resources, and meal delivery if you have Covid. For those who do not qualify for CLS, Papa Pals is an alternative means of assistance with cooking, cleaning, transportation, or other tasks that CLS might include.

Benefits are dependent on your Priority Health Plan. Contact a representative for details.

LifeCircles PACE

LifeCircles PACE provides an in-home alternative to traditional nursing home living through all-inclusive services and support in homes and at our day centers.

Eligibility

- People wishing to enroll in LifeCircles PACE must meet the following criteria:
- Be age 55 or older
- Live in anywhere in Muskegon County and portions of Ottawa and Allegan Counties
- Meet the State of Michigan's Nursing Home Level of Care Criteria
- Be able to live safely in their home with community and LifeCircles PACE supports

Resource Navigation

Disability Network Lakeshore

Gracious Grounds partners with Disability Network Lakeshore (DNL) and highly recommends reaching out to them if assistance is needed with navigating resources available for adults with disabilities. Services include assessing readiness for independent living, finances, circle of support and guardianship, skill development, employment, life transitions, social security, assistance animals, and connecting you with any other resources you may need. DNL operates under five umbrellas:

- Information and Referral: As a network, they have connections with other agencies, government programs, non-profits, and businesses, which collectively have access to a vast array of resources and services. Feel free to contact them with questions.
- *Transition:* They help people with disabilities transition in and out of schools, the workforce, and nursing homes.
- *Peer Support:* You are not alone. There are a number of people in the West Michigan lakeshore area with disabilities. They help connect people with disabilities for social support to join them in their journeys together.
- Advocacy: Disability Network Lakeshore believes people with disabilities are most independent when they learn to speak on their own behalf. DNL offers education and coaching that helps individuals effectively communicate their specific needs and interests. On a systems level, DNL seeks to learn from other service providers. They strive to understand their processes and constraints and then work to build collaborative relationships that recognize the diversity of disability.
- *Skills Development:* They want to empower people with disabilities. Having access to training programs, they can help teach you basic and advanced skills for living independently.

Eligibility

DNL serves people with any kind of disability, including some that may be "invisible," such as learning disorders. Instead of focusing solely on the disability, they address the needs of the whole person so they can achieve a more balanced life.

- BSBP Training Center: a residential facility located in Kalamazoo that teaches independent living and workforce skills.

Social Security Information

Description

The Social Security Administration (SSA) administers two programs that provide benefits to persons with a disability:

- The Social Security Disability Insurance (SSDI) program [Title II of the Social Security Act] provides payment of benefits to eligible individuals.
- The Supplemental Security Income (SSI) program (Title XVI of the Social Security Act) provides SSI payments to individuals with a disability (including children under age 18) who have limited income and resources.

The major difference is that SSI determination is based on age/disability. and limited income and resources, whereas SSDI determination is based on disability and work history. It is possible to have both benefits if you have both limited income and a work history.

Factor	SSI	SSDI
Eligibility Based On	Age (65+) OR blindness (any age) OR disability (any age) AND limited/no income and resources	Disability AND sufficient work history through own/family employment
When Benefits Begin	1st full month after the date the claim was filed or, if later, the date found eligible	6th full month of disability; 6-month period begins with the first full month after the date SSA decides the disability began
Health Insurance	Automatically qualifies for Medicaid upon receipt (in most states)	Automatically qualifies for Medicare after a 24-month waiting period from time benefits begin (no waiting period for persons with Lou Gehrig's disease/ALS)

Comparison of SSI and SSDI

Eligibility

The Social Security Act prescribes rules for deciding if an individual is eligible for benefits. For more details about how children and adults can qualify for benefits, please go to: https://tinyurl.com/ssabdq The Social Security Administration defines disability as the inability to engage in any substantial gainful activity by reason of any medically determinable physical or mental impairment(s) which can be expected to result in death, or which has lasted or can be expected to last for a continuous period of not less than 12 months. A child under age 18 would be considered a person with a disability if he or she has a medically determinable physical or mental impairment or combination of impairments that causes marked and severe functional limitations, and that can be expected to cause death or that has lasted or can be expected to last for a continuous period of not less than 12 months.

Helpful Hints

 There are several ways you can apply for SSI and SSDI benefits at the same time. You can apply online at the following link: https://tinyurl.com/ssaapply Then click 'apply for disability'



- If you are not able to complete the application in one setting, it is very important that you save what you have completed in the application process, so you can go back and complete the rest of the application at a later date.
- You can also apply by calling the Social Security office. The representative will make an appointment with you to complete your application over the telephone. You can also schedule an in person interview to receive the help applying for disability benefits.
- The Social Security Administration created a checklist to help you get ready for your appointment or when filing online. Make sure you have the following:

- Your Social Security card or a record of your Social Security Number
- Your birth certificate or other proof of your age
- Information about the home where you live, such as your mortgage or your lease and landlord's name
- Payroll slips, bank books, insurance policies, burial fund records, and other information about your income and the things you own
- The names, addresses, and telephone numbers of doctors, hospitals, and clinics you have been to if you are applying for SSI because you are disabled or blind
- Proof of U.S. citizenship or eligible noncitizen status
- Medical records already in your possession. SSA will help get the rest of your records
- Workers' compensation information, including the settlement agreement, date of injury, claim number, and proof of other disability awarded payment amounts
- Names and dates of birth of your minor children and your spouse
- Dates of marriages and divorces
- Checking or savings account number, including the bank's 9-digit routing number
- Name, address, and phone number of a person to contact if SSA is unable to reach you
- An estimated 70% of applicants are denied the first time they apply for Social Security Disability benefits. Please do not get discouraged if you are denied benefits. It is important and helpful to seek out an attorney that specializes in disability benefits that can help you in the appeal process. Employment

Disability Network Lakeshore (DNL)

DNL offers a variety of employment services to help individuals with disabilities prepare to join the workforce for the first time, return to work, or maintain employment. DNL also provides resource navigation and other services noted in the Resource Navigation chapter of this guide.

Eligibility

DNL serves people with any kind of disability, including some that may be "invisible," such as learning disorders.

Michigan Rehabilitation Services (MRS)

MRS is a statewide network of vocational rehabilitation (VR) professionals developing creative, customized solutions that meet the needs of individuals and business. MRS delivers individualized services that assist potential employees with differing abilities to prepare for, pursue and retain careers.

Eligibility

A person with a disability may be eligible for MRS if the disability causes problems in preparing for, finding, or keeping a job. MRS can also help with wage reporting.

Food

Supplemental Nutrition Assistance Program (SNAP)

SNAP, formerly known as food stamps, provides funds to buy groceries. These funds can be loaded onto a Bridge Card, also known as an Electronic Benefit Transfer (EBT) card, and can be used to purchase groceries like you would using a credit or debit card. SNAP benefits can be used to buy food, seeds, and plants. It cannot be used to buy alcohol, tobacco, non-food items, vitamins, or prepared hot foods.

Eligibility

Participants must be a U.S. citizen, or a non-citizen meeting one of the following criteria: 1) have lived in the U.S. for at least 5 years, 2) receive disabilityrelated assistance or benefits, or 3) are under the age of 18. Eligibility is based on all members of a household. Everyone who lives together and purchases and prepares food together is considered a member of the same household. The program reviews the household's expenses, assets, and income to determine eligible benefits.

SNAP Double Up Food Bucks (DUFB) Program

People who receive SNAP are often automatically eligible for other programs, such as the Double Up Food Bucks (DUFB) program. At participating DUFB grocery stores and farmer's market locations, shoppers who have SNAP can get up to \$20 in tokens to purchase Michigan-grown fruits and vegetables.

Dual Special Needs Plan

A Dual Eligible Special Needs Plan is a managed care plan for people who qualify for both Medicare and state Medicaid assistance or Medicaid. A D-SNP combines multiple coverages and coordinates Medicare and Medicaid benefits to make them easily accessible to people who have both. Dual health plans usually include transportation assistance. These plans include many extra benefits and features to help make life easier. You typically get a set number of one-way rides to health appointments at no cost to you. Transportation coverage may include appointments with health providers, adult day care and other community services, and picking up prescriptions and medical supplies.

Eligibility

Enrolled in a Dual Special Needs Plan. Each insurance carrier will have specific requirements.

Vehicle Purchase Assistance through Michigan Department of Health and Human Services (MDHHS)

MDHHS may help with purchasing a vehicle or making repairs to a vehicle.

Eligibility

Vehicle Repairs

The State Emergency Relief (SER) Program provides immediate help to individuals and families facing conditions of extreme hardship or for emergencies that threaten health and safety. The amount paid by MDHHS may not exceed \$900 (this may change) including any repairs done in the previous 12 months by MDHHS/MI Works. The repair is expected to make the vehicle safe and roadworthy (verification will be required). The cost of the vehicle repairs will not exceed the vehicle's retail value.

Eligibility
